

DWC MONTHLY UPDATE APRIL 2014

Financial Overview

February saw some reasonable returns in the equity markets and this means DWC is now tracking slightly ahead of its income target for the year. Operational expenses continue to be on or below budget however the Trust's year to date profit of \$2.88m is \$800k behind budget due to the accrual of \$1.5m of grants to projects in the region.

Total assets at the end of February were \$119.7m and equity is \$105m.

Pool of West Coast leaders growing

he West Coast's next generation of leaders is continuing to grow with a third group starting an intensive training programme to hone their leadership and governance skills.

This is the third Leadership and Governance course to be run on the West Coast with previous graduates already stepping up to take on board positions. DWC launched the programme in partnership with Westland Milk Products in 2011 with the aim of raising the professional governance skills of business people from a variety of backgrounds.

"It's a great success and our graduates are getting shoulder tapped to join boards. The Leadership & Governance programme provides people with the knowledge and skills to give them the confidence to return to their communities and make themselves available for these board positions," says DWC Business Support Manager Nelia Heersink.

The 13 participants on the latest course are sponsored by local businesses and this year come from Westland Milk Products, Grey District Council, DOC, FT Dooley Ltd, Martin & Co Mitre 10, Buller Electricity, Buller Holdings and Chris J Coll Surveying Ltd.

Steven May from Grey District Council says the opportunity to have such a high quality programme on the West Coast is fantastic.

The experience of meeting other people wanting to develop their governance skill-set has been really refreshing. We are all likeminded and wanting to learn from the experts and each other," he says.

Cornelia Vervoorn from DOC agrees. "A great benefit is creating links between people and different industries, which gives you an understanding about the challenges everyone else is facing. Knowing what makes businesses tick means DOC can work with them better as we can speak the same language," she

Funding brings "colour" to **Westport rest home**

These days when O'Conor Home General Manager Susan Watson looks around the Westport aged care facility she is overwhelmed by the brightness.

"It is beautiful and colourful, looking down the corridor it is like looking at a rainbow. The residents are delighted," she

O'Conor Home has just completed the first stage of a five stage upgrade to extend and earthquake strengthen the rest home. The \$3 million first stage has seen two new lounges and a dining room built and bed numbers extended from 34 to 53.

"It has made a huge difference. The rooms are bigger, the corridors are wider and we now have ensuites between two rooms. We have always been 100% occupied and have had to turn people away so it is wonderful to have more beds available," says Mrs Watson.

After the Christchurch earthquakes O'Conor Home's insurance premiums increased substantially, so stage two involves earthquake strengthening the old part of the building to 100% of code to bring premiums

O'Conor Home is run by a Trust which was set up by local Westport identity Eugene It offers day care, respite care, hospital level care, dementia care, palliative care, and residential care to residents currently aged from 51 to 99 years of age.

The O'Conor Home Trust raised the

funds to undertake the strengthening and extensions in a variety of ways including

donations and bequests, selling a farm attached to the home, selling rooms and sponsoring bricks. They were also granted sponsoring bricks. \$200,000 by the Buller District Council from the \$2 million Extraordinary Distribution Fund provided to the council by Development

West Coast.
"The funding from DWC was hugely important, it got us over the hump stage to start the project and is greatly appreciated," says Mrs Watson.

DWC Chair John Sturgeon says Trustees were happy to see some of the funding go to the O'Conor Home project.

"It is great that people who live in O'Conor Home are seeing the benefits from this money. They have contributed to the district in their own ways and been pioneers of Buller and the rest of the country," he says.

O'Conor Home aims to extend the rest home to 85 beds in the coming years.
